Reason for Notification

The Sensitech Inc. and FreightWatch International (FWI) products identified above should be shipped via **air and ground** in accordance with U.N. 3481: Packing Instruction (PI) 967 (Lithium Ion Batteries Contained in Equipment) Section II and Packing Instruction 966 Section II (Lithium Ion Batteries Packed with Equipment)– “Excepted Lithium Ion/Polymer Cells and Batteries,” and DOT 49 CFR Part 171-180. All products containing Lithium Ion or Polymer Batteries meet General Requirements under PI 967 and PI 966. Please note that this CSB is in compliance with the Final Rule by Pipeline and Hazardous Materials Safety Administration, DOT, published August 6, 2014.

All Sensitech and FWI products meet the current documented requirements by both IATA and DOT. In compliance with DOT requirements for “Lithium Battery - Hazardous Material Regulations” 49 CFR Part 171-180, and 2016 IATA Dangerous Goods Regulations 57th Edition, Sensitech Inc. and FreightWatch International have performed all necessary testing and can provide documentation supporting compliance upon customer request.

Labeling Requirements:

- Lithium Ion Battery Handling Label (below)
- Each consignment with packages bearing the Lithium Battery Handling Label must be accompanied with a document indicating that:
 - the package contains Lithium Ion Cells or Batteries;
 - the package must be handled with care and that a flammability hazard exists if the package is damaged;
 - special procedures must be followed in the event the package is damaged, to include inspection and repacking if necessary; and
 - a telephone number to call for additional information.
- The words “Lithium Ion Batteries in compliance with Section II of PI 967 (or 966)” must be included on the air waybill, when an air waybill is used. The information should be shown in the “Nature and Quantity of Goods” box of the air waybill.

Note: Supporting documentation available upon request includes product data safety sheets from the specific battery manufacturers and the caution label displayed below.
